**In Association with National Beef Packing Co. Recall  
ALDI Voluntarily Recalls Approximately 3,200 Pounds of Ground Beef**

**Batavia, Ill.** (Aug. 2, 2013) In cooperation with Kansas-based National Beef Packing Co., ALDI has voluntarily recalled approximately 3,200 pounds of its All Natural Lean Ground Beef (93% Lean only) due to possible E coli O157:H7 contamination. Upon notification, ALDI immediately removed the affected product from the stores' selling floor. No other ALDI products are affected by this recall.

While no illnesses have been reported, ALDI initiated the voluntary recall of All Natural Lean Ground Beef (93% Lean only) as a precautionary measure in case customers have the affected product in their homes. All Natural Lean Ground Beef (93% Lean only) affected by this voluntary recall was available in ALDI stores in the following states: Kentucky, Indiana, Michigan, New Jersey, New York, Ohio, Pennsylvania and West Virginia.

The All Natural Lean Ground Beef (93% Lean only) product affected by this voluntary recall has the use or freeze by date of Aug. 7, 2013, and is in an approximately 1-pound black tray pack, with a clear film wrap and a green label on the front of the package. The UPC code of the affected product begins with these six numbers, 242247, and can be found on the back of the package. Additionally, the establishment code of the affected product can be found on the green label on the front of the package and is listed as Est. 21526.

At ALDI, we take the safety and integrity of the products we sell very seriously. If customers have product affected by this voluntary recall, they should discard it immediately or return it to their local store for a full refund.

The U.S. Department of Agriculture's Food Safety and Inspection Service advises all consumers to safely prepare their raw meat products, and only consume ground beef that has been cooked to an internal temperature of 160° F.
