**In Association with Jac. Vanderberg Inc., ALDI Voluntary Recalls Rio Duero Peaches, Nectarines and Plums from Limited Stores**

**Batavia, Ill.** (January 25, 2019) – In cooperation with Jac. Vanderberg Inc., and out of an abundance of caution, ALDI has voluntarily recalled Rio Duero peaches, nectarines and plums that were available for purchase in select stores due to possible *Listeria monocytogenes* contamination.

Upon notification from the supplier, ALDI immediately removed the affected products from its stores.
